Executive Director's Update

A tremendous amount of time and effort has been put into planning the Fall Conference since we last met at the summer management team meeting on July 14, 2017. The Technology Team began the process of transitioning from the current Your Membership website software to Member Clicks. The tentative "Go-Live" date is February 2018. Also, UVA has agreed to create a Cohort program that meets the needs of the SFO certification program, which is a nationally recognized certification program. A joint UVA & VASBO meeting is scheduled for late September to work out the details with the goal of starting the program in January 2018. The 2017 Fall conference and hotel registrations were opened mid-August to provide more lead time for planning and registration purposes. VASS and VASBO will host a Joint Winter conference at the Richmond Marriott on January 10 and 11, 2018. In addition, a memorandum of understanding was drafted and executed to delineate the roles and responsibilities between VASS and VASBO during the Winter Conference. Moreover, at the Joint Winter Conference, Horace Mann will present four (4) \$1,000 scholarships to school business officials who plan to enroll in the UVA/VASBO SFO Certification Cohort Program.



VASBO Strategic Plan and Input

At the Winter 2015 Conference, VASBO embarked upon drafting a Strategic Plan document to add to its rich history. VASBO's strategic plan provides a blueprint to enhance professional development offerings, member and vendor engagement, and fiscal sustainability. - b. Expand vendor involvement in ways that will provide fiscal support to VASBO and/or add value to VASBO membership.

Goal 5 - Membership Engagement & Networking

Retain and grow membership in VASBO through relevant membership engagement.

Objectives

- a. Maximize involvement by recruiting and utilizing volunteers.
- b. Enhance value of membership for all business officials including those who are new to school business.
- c. Establish and promote quarterly regional meetings to encourage networking and collaboration throughout the year.

The School Finance Officer (SFO) Credential: Why Should I Bother?

Why should I become a SFO? I have asked myself this question quite a few times over the last couple of years and I always come back to the fact that I have an earnest desire to increase my skills so I can do the best job possible for the children of my school district. We are blessed here in Virginia to have a fine group of dedicated professionals who work tirelessly to meet the needs of students across vast demographics. While many of us are trained accountants, not all of us began our career with the end goal of School Finance Officer in mind. Sadly, we have witnessed some Certified Public Accountants (the former sole credential to exemplify professional competence) struggle to adjust to the intricacies involved in public school finance. While one could argue that good accounting practices are good accounting practices, we all know that there is no other organizational structure quite like the one which exists in public education. One must become aware of these differences and how to avoid the pitfalls which could jeopardize the financial condition of the organization and cause irreparable damage to one's professional career.

For those of you beginning your career, the initials SFO behind your name will go a long way in opening doors for you as you progress up the ranks of administration. When Human Resource Directors see this credential they will automatically know that you have the requisite knowledge base to direct the financial operations of their school divisions. School Boards strive to assure their citizenry that they are good stewards of any and all funds entrusted to them. Thus, having a highly qualified SFO at the financial helm of a school division goes a long way in providing the important assurance that funds are handled with transparency and discernment. Increased competition from virtual and online education services coupled with the penchant that legislators have for charter

and private education providers, the competition for the tax dollar will become even greater. We must prove that we are worthy and uniquely capable to merit the investment of trust and dollars to provide the very best education possible for our students.

For those of you who want to travel and expand your horizons, not only is this standard recognized in Virginia, the SFO designation is recognized across the United States and Canada. Odds are that those entering the workforce, or those who have recently entered the profession, will be more mobile than any of the generations which have gone before. Having a credential which is widely recognized as the industry standard will go a long way in leveling the playing field as you compete for positions across our great nation and beyond.

Finally, for those of us rounding out our careers and still hoping to make a difference, the SFO designation is validation that you have acquired the knowledge and training to be an expert in your field. You can rest assured that you did what was in your power to make a difference in the life of a child. When one looks at the SFO credentialing in this manner, how could anyone not believe that the SFO is a priceless designation?

I am, and have always been, proud of the work that VASBO has done in supporting the work of the local School Business Officials. With tight budgets and limited funds, staff development opportunities are many times few and far between. Without the offerings provided by VASBO, many small divisions would be left behind and the negative impact upon school divisions immense. Embarking upon this new challenge of providing training opportunities to prepare members for the rigors of a national certification program shows me that VASBO is headed in the right direction and that the Commonwealth of Virginia will continue to be in good hands.

Virginia Cardinal Award

The Virginia Cardinal Award is VASBO's premier recognition given to one of its members each year for exemplifying professionalism, leadership, and innovation in the field of school business management. The award winner is announced at the Spring VASBO conference. The winner also attends the Southeast Association of School Business Officials (SASBO) conference as VASBO's distinguished guest.

The 2017 Cardinal Award winner is **Tina Cropp**, Director of Finance for Madison County Public Schools for over 18 years. She is also starting her third year



as a Director for VASBO and was in the first cohort to complete the UVA/VASBO certification program. Tina has been instrumental in coordinating a regional group of finance directors called the "Wizards" since 2008. In one of her Cardinal Award nominations, she was cited for her strong mentorship of a new finance director in a nearby school division and her assistance to staff in the absence of that finance director during a critical seven week period. As a finance director in a small school division, she wears many hats including payroll and benefits coordinator, deputy clerk, and member of the school/county CIP committee. According to her superintendent, Dr. Matthew Eberhardt, she is a "difference maker"--she is valued for her focus on people, especially the students and staff, but also with peers, elected officials and all stakeholders; and her high professional standards.
